

Auxiliary Resident Remote Device Application Form

Resident homeowners may lease auxiliary remote devices, provided that the resident can demonstrate ownership of more than two (2) licensed vehicles. Auxiliary remote devices are intended for use with cars, trucks, motorcycles and RV's in excess of the two (2) remote devices allowable per household. Residents are limited to no more than two (2) auxiliary remote devices per household per additional vehicle.

Auxiliary remote devices will not be provided to vehicles not registered to the resident homeowner. Auxiliary remote devices will also not be provided for commercial vehicles, ATV's, off-road motorcycles or non-motorized vehicles. Remote devices are not transferable or saleable.

To obtain auxiliary remote devices, the resident must complete this form, provide photocopies of vehicle registration for ALL vehicles and submit the required fees. The cost of leasing auxiliary remote devices is thirty dollars (\$30.00) per device. Twenty dollars (\$20.00) per operable remote device is refundable as a deposit. All information provided on this form is confidential.

All access codes and remote gate openers are intended for use ONLY by the individual household making this application. The individual applying for this privilege will be held responsible for the proper use of issued codes and devices. You may not share an access code or remote device with any unauthorized person or party. Codes and remote devices are non-transferable. Codes and remote devices may be reprogrammed without prior notice at the discretion of the 3 Canyons Gate Committee.
